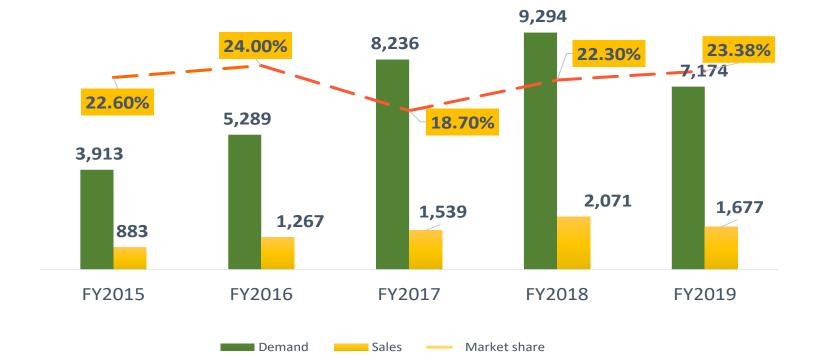
- 1. FY2019 demand of H/E (Excavator 6T over) decreased 23% and actual sales decreased 19% compared with same period of FY2018.
- 2. Market share was increased 1.7% from 22.3% to 23.4%, although from the quantity point of view was decreased around 19%
- 3. PS sales in FY2019 was 95% against FY2018 due to slowing down an overall economical condition in 1st quarter of year 2020 and mining activity decrease followed by part sales & maintenance during FY2019.
- GP margin of machine and PS improve in FY2019 about from 21% become 25%. GP ratio part increased from 37.4% to 41% and service & FMC increase 37.1% to 49.3%

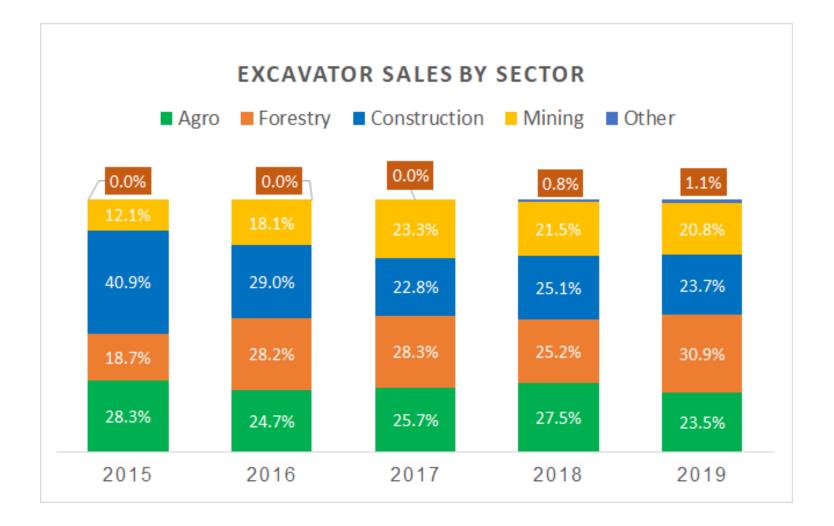
Market Share – Excavator 6Ton up



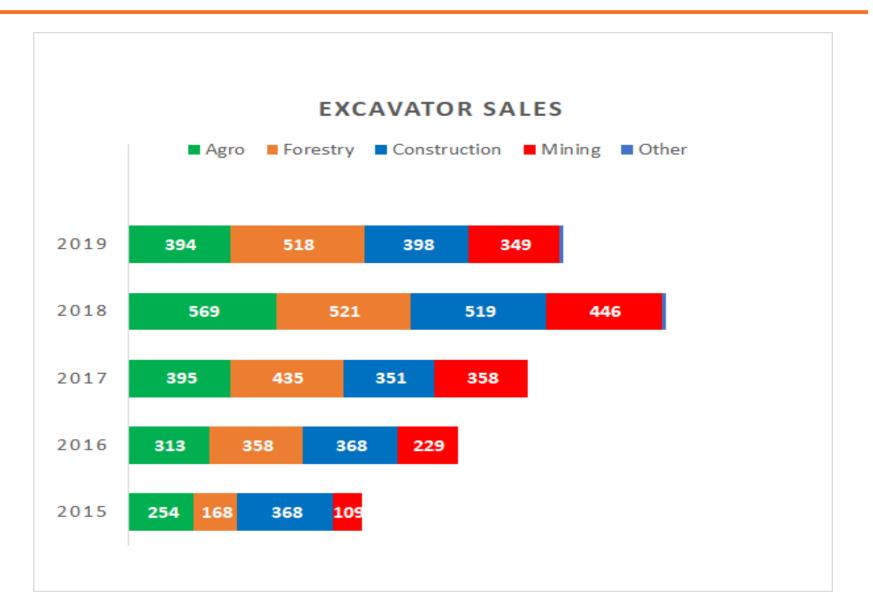
